## Hello FOML Family,

2022 has seen a number of public libraries across the United States face strong challenges to books available to youth and adult patrons. Challenges are happening in Michigan. Voters in Jamestown Township voted to defund their only library, due to complaints that some books were pornographic, and library staff was indoctrinating children. Other communities are seeing candidates for library board positions campaign specifically to challenge item selection.

What options are available for Friends to support our public libraries, during these challenging times? An understanding of how librarians select books is very helpful. Collection Development Policies, written by librarians and adopted by the local library board, are available for any patron to read. Becoming familiar with your library's Policy is an excellent beginning step.

The Michigan Library Association offers an extensive online guide to Intellectual Freedom and the Right to Read. At www.milibraries.org you can find sample Collection Development policies, as well as practical ways to advocate for your library.

# Why Freedom to Read Matters

The Freedom to Read Foundation is an American non-profit anti-censorship organization, established in 1969 by the American Library Association (ALA). The organization has been active in First Amendment-based challenges to book removals from libraries, and in antisurveillance work. The freedom to read is essential to our democracy. We. as citizens devoted to reading and as librarians and publishers responsible for disseminating ideas, wish to assert the public interest in the preservation of the freedom to read.

Most people understand that the First Amendment gives them a right to speak on any subject, free from censorship by government officials. Probably fewer people realize that the U.S. Constitution implicitly grants the freedom to read what they choose and protects their right to read in privacy.

Freedom to read is closely aligned with intellectual freedom which encompasses the freedom to hold, receive and disseminate ideas. Intellectual Freedom is important because it is essential for a democratic system of governance. To govern themselves responsibly, people must be well-informed.

According to the ALA Library Bill of Rights (adopted in 1948) "there should be the fullest practicable provision of material presenting all points of view" and "censorship of books ....must be challenged by libraries in maintenance of their responsibility to provide information and enlightenment through the printed word." Each of us wants to enjoy the freedom to access the library and the materials it contains and we value the freedom to read what we choose to read without a restrictive imposition of censorship.

Friends of the library can play a vital role in support of freedom to read and intellectual freedom by supporting these principles whenever there are challenges to access to library materials. Read the ALA Library Bill of Rights and there will be statements in that document that you can use to verify the value of reading in our democratic society.
